BOARD ORDER 2010-10

WHEREAS:

- A. On September 28, 2010, Yukon Energy Corporation (YEC or Company) filed an application with the Yukon Utilities Board (Board) seeking an Order approving the Purchase Power Agreement (PPA) between YEC and Alexco;
- B. The application states that Alexco who intends to develop mines and mills in the Mayo-Keno area, is to be connected to the transmission facilities in early October and is to commence service as a major industrial customer (as defined in OIC 1995/90) by mid-October 2010;
- C. The PPA includes provisions whereby Alexco will pay YEC for the reasonably incurred costs related to the initial mine facilities spur, capital costs for any other mine facilities, costs to negotiate and conclude the PPA and decommissioning costs;
- D. Section 6.1 of the PPA also seeks approval to issue only one bill totaling the Electric Demand and Electric Energy at the Points of Delivery;
- E. YEC is also seeking approval for the Alexco Fixed Charge of \$7,289 per month as defined in Schedule A of the PPA;
- F. Seeing the limited scope of the application, the Board is of the view that the application will be determined by way of a written proceeding.

NOW THEREFORE the Board orders as follows:

1. The following process schedule is adopted for this PPA proceeding:

2. No later than November 5, 2010, YEC will arrange for publication in display-ad format, of a Notice of Application as per the attached Appendix A, in such appropriate local news publications in the service area of the company so as to provide adequate notice to the public.

3. The Application and supporting material are to be made available for inspection at the Head Office of Yukon Energy Corporation, Whitehorse Hydro Dam, Robert Service Way and at the District Offices located at Mayo, Faro and Dawson, Yukon as well as Yukon community and public libraries.

The application and supporting material are also available for inspection at the office of the Board, 19-1114 First Avenue, Whitehorse, Yukon.

4. YEC is to distribute copies of the Application and any supplemental information to all interested parties that were registered in its 2008-2009 GRA (Phase I) and Mayo B proceedings as well as any new Intervenors as they become registered with the Board in this proceeding.

Written Proceeding

An application was filed by Yukon Energy Corporation (YEC) pertaining to a Purchase Power Agreement between YEC and Alexco Resource Corp.

Summary of Application

On September 28, 2010, Yukon Energy Corporation (YEC) filed an application with the Yukon Utilities Board (Board) seeking an Order from the Board for approval of the PPA between YEC and Alexco. The Board has determined that a written proceeding is appropriate to review the application. The Board Chair for review of this application is Bruce McLennan.
