BOARD ORDER 2008-15

WHEREAS:

- A. On October 6, 2008, Yukon Energy Corporation (YEC) filed with the Yukon Utilities Board (Board) an Application, pursuant to the *Public Utilities Act* and Order-In-Council 1995/90, requesting an Order approving forecast revenue requirements for the 2008 and 2009 test years of \$29.217 million for 2008 and \$31.599 million for 2009 (General Rate Application or Application).
- B. The Application also requests approval of an Interim Refundable Rates for retail rate reductions (Rider U) commencing November 1, 2008, which was subsequently amended to December 1, 2008, applicable only to first block rates where feasible, without any rate rebalancing between customer classes. YEC also requests that an increase in residential run-off rates be approved as part of an Interim Refundable Rates Order (Interim Application).
- C. The Board has reviewed the Application and requires that a Pre-Hearing Conference and Hearing process be established.
- D. In response to YEC's request for approval of Interim Refundable Rates, referred to in item B, above, the Board issued a letter on October 17, 2008, inviting submissions from interested parties.
- E. The Board is considering YEC's request for approval of Interim Refundable Rates and the submissions received from interested parties, and will issue a decision on this matter in due course.

NOW THEREFORE the Board orders as follows:

1. A Pre-hearing Conference into the Application will commence at 9:00 a.m. on January 7, 2009, at the High Country Inn, 4051 Fourth Avenue, Whitehorse, Yukon.
2. Persons intending to participate in the Pre-Hearing Conference and subsequent hearing process, or who wish to receive documentation only, are to register in writing with the Board Secretary no later than December 5, 2008, indicating the nature of their interest.

5. YEC shall make the Application and supporting material available for inspection at the Head Office of YEC, No 2, Miles Canyon Road, Whitehorse, and at its District Offices located at Mayo, Dawson and Faro, Yukon.
6. The Board will also make the Application and supporting material available for inspection at the office of the Board, 19-114 First Avenue, Whitehorse, Yukon.

7. YEC shall distribute copies of the Application and any supplemental information to Intervenors registered with the Board, if the Application was not previously sent to them.

Summary of Application

The Yukon Energy Corporation (YEC) has filed an application with the Yukon Utilities Board (Board) for approval of its proposed revenue requirements for the years 2008 and 2009 (Application). YEC is the main generator and transmitter of electrical energy in the Yukon and provides electrical service directly to more than 1900 retail customers in and around Dawson City, Mayo and Faro and, indirectly, to retail customers on the Whitehorse/Aishihik/Faro system and Mayo-Dawson system through its wholesale sales.

YEC is seeking approval of revenue requirements of \$29.217 million for 2008 and \$31.599 million for 2009.

YEC is also requesting approval of interim refundable rate riders effective December 1, 2008.

YEC Workshop

YEC will hold a workshop to provide a summary of its Application commencing at 1:00 p.m. on Monday, **January 6, 2009**, at the Gold Rush Inn, 411 Main Street, Whitehorse, Yukon.
