BOARD ORDER 2010-8

WHEREAS:

- A. On February 19, 2010, Yukon Electrical Company Limited (YECL) and Yukon Energy Corporation (YEC) (jointly, the Companies) filed with the Yukon Utilities Board (Board), pursuant to the *Public Utilities Act* (Act), and *Order-In-Council 1995/90*, an Application requesting an Order approving adjustments to rates (on a prospective basis), to be effective September 1, 2010 and to collect an approved 2009 Consolidated Firm Rate Revenue Requirement of \$50.833 million.
- B. The Board through Board Order 2010-6 issued a process schedule and requested parties intending to participate in the review process to register in writing with the Board Secretary no later than May 17, 2010.
- C. The Board through Board Order 2010-7 revised the Proceeding Schedule at the request of YEC.
- D. On July 7, 2010 the Board received correspondence from YEC and YECL requesting an extension for information responses from July 12, 2010 to July 23, 2010. The Board set up a process asking for comment from intervenors by 5:00 PM Friday, July 9, 2010.
- E. Comments were received from Keith Lay, the City of Whitehorse, and the Utilities Consumers' Group. None objected to the request for an extension to respond to information requests from YEC and YECL. Both the City of Whitehorse and the Utilities Consumers' Group commented that it may be necessary to adjust other portions of the proceeding schedule.
- F. The Board has reviewed the submissions and made a determination on the request by YEC and YECL.

NOW THEREFORE the Board orders as follows:

1. The Board accepts the request of YEC and YECL and grants an extension for information responses to 5:00 PM Friday, July 23, 2010.
2. Due to the extension for information responses, the Proceeding Schedule is amended as follows:
