Re: Yukon Energy Corporation (YEC) Mayo B Hydro Enhancement Project – YUB Hearing Scheduling

The Yukon Utilities Board (Board) hearing process with respect to the Mayo B energy project and energy operation certificate is now well underway. The first Board Order (2010-1) was issued on January 25, 2010 in order to communicate both the Terms of Reference for the hearing, as outlined in your December 18, 2009 direction to the Board, as well as, to request that potential intervenors and observers make application for standing in the hearing by the date of February 8th. On February 12, the Board issued our second order (2010-2), in order to approve intervenor and observer status, as well as to identify the return dates for intervenor information request to YEC and the concomitant intervenor responses from YEC.

To date the Board has not issued the full hearing schedule. The Board felt it was prudent to wait for the applications for intervenor status so that we could gauge the scope of issues that intervenors might raise. It is evident from the intervenor applications received that the ranges of issues that intervenors have identified are varied and wide-ranging in their areas of interest. Based on the Board's review of these intervenor applications it is apparent to the Board that the full hearing process cannot occur within the March 31st deadline established by the Yukon Government's OIC, and at the same time ensure a fair, transparent and comprehensive review, including the requested oral hearing process.

In order to conduct a fair hearing, the Board has to provide intervenors with an opportunity to review the application, to ask questions, to file evidence and to allow time for the applicant and the intervenors to prepare for a hearing. All these process steps require time. After the hearing, the Board has to consider the evidence filed and prepare its report.

Given that the application review process has already formally begun, it is imperative that the Board shares all correspondence with the applicant and intervenors to guarantee full transparency.
