WHEREAS Yukon Energy Corporation ("**YEC**") filed a letter with the Yukon Utilities Board ("**the Board**") on October 1, 1992 indicating that, pursuant to the June 1, 1991 amendment to the Supply Agreement between Curragh Resources Inc. ("**Curragh**") and YEC, the Curragh base load for the first three (3) billing months of the 1993 calendar year is established for each hour equal to 19,977 kilowatt hours;

AND WHEREAS Section 8.(2) of Order-in-Council 1991/62 reads:

"Notwithstanding subsection (1), the Board must ensure that rates charged to Curragh Resources Inc. and United Keno Hill Mines Limited by Yukon Energy Corporation conform with any contract between Yukon Energy Corporation and Curragh Resources Inc. or United Keno Hill Mines Limited.";


AND WHEREAS the Curragh base load referred to in Rate Schedule YEC-39 effective March 1, 1992 reads 18,836 kW.h [sic] [kW];

NOW THEREFORE IT IS ORDERED THAT:

1. The rates, tolls or charges by Yukon Energy Corporation to Curragh Resources Inc. as set out in Schedule "A" attached hereto be and the same are hereby fixed and approved as final rates to be effective for billings issued on and after January 1, 1993.



RATE SCHEDULE YEC - 39**INDUSTRIAL PRIMARY****AVAILABLE:**

To Curragh Resources

APPLICABLE:

To industrial primary (138 kV) supply to Curragh Resources at Faro, Y.T. from the Whitehorse/Aishihik system.

RATE:

Charges for service in any one billing month shall be the sum of the following:

(a) Demand Charge \$18.60/kV.A(b) Base Load Energy ChargeEnergy that does not exceed
Curragh Base Load (19,977 kW
multiplied by the number of hours
in the billing month)

1.434¢/kW.h

(c) Other Charges

Payment of the following charges:

(i) Excess Energy Charge as specified by
contract for energy in excess of
Curragh Base Load

(ii) Fixed Charge of \$21,446 per month

(iii) Surcharge of 0.1619¢/kW.h as
specified by contract**MINIMUM
MONTHLY BILL:**

The sum of the Demand Charge and Fixed Charge.

Rate Schedule YEC - 39 (Continued)

BILLING DEMAND:

Shall be the greater of:

- a) the current month's maximum kV.A demand or
- b) the maximum kV.A demand experienced during the previous 12 month period ending with the current billing month.

**RATE MODIFICATIONS
APPLICABLE:**

For fuel adjustment rider, see Rider F. Rider F applies to Curragh Base Load only.

**ELECTRIC SERVICE
REGULATIONS:**

The Company's Electric Service Regulations approved by the Yukon Utilities Board form part of this rate schedule and apply to the Company and every customer supplied with electric service by the Company in the Yukon and British Columbia. Copies of the Electric Service Regulations are available for inspection in the offices of the Company during normal working hours.
