ORDER 1997-1

WHEREAS:

- A. On December 20, 1996, the Yukon Utilities Board issued Order #1996-11 with respect to the recovery of revenues previously denied to Yukon Energy Corporation and the Yukon Electrical company Limited; and
- B. The Anvil Range Mining Corporation (ARM) submitted a request for the Yukon Utilities Board to reconsider its decision on December 30, 1996. That request was copied to all interested parties on December 31, 1996.
- C. The Board considers the ARM request to be a matter for an expedited decision as Order #1996-11 is scheduled to take effect on February 1, 1997.

NOW THEREFORE the Board orders as follows:

- 1. Intervenors and Interested Parties wishing to do so are invited to make written submissions on ARM's request contained in its letter of December 30, 1996.
- 2. Submissions are to cover both whether or not the Board should review its decision pursuant to Sec. 62 of the *Public Utilities Act* as well as submissions with respect to whether the Board should or should not vary its decision, in the event that the Board determines that a review should be granted.
- 3. All submissions are to be received by the Board by January 16, 1997, following which the applicant will have until January 24, 1997 to submit written reply.

Re: Anvil Range Mining's Request for a Review of Order #1996-11



The Yukon Utilities Board had occasion, on November 7, 1996, to distribute guidelines for an application for review pursuant to Section 62 of the *Public Utilities Act* and I enclose a copy to assist you with any submission you may have.

Due to timing, the Board intends to follow an expedited process. In making their submissions, the parties should have regard to the matters set forth in the guidelines. In particular please note that parties are being requested to deal with both phase one and phase two at the same time.
