ORDER #1997-2

WHEREAS on December 20, 1996 the Board issued Order 1996-11 wherein it ordered that:

- "1. The Companies are entitled to recover an amount of \$1,952,912 from customers pursuant to the directions contained in the April 9, 1996 judgment of the Court of Appeal.
2. The Companies are directed to submit to the Board within seven days of the date of this Order, for the Board's approval, a rider which is designed to recover the amount of \$1,952,912 from customers over a period of approximately 12 months.";


AND WHEREAS under cover of letter dated January 17, 1997 the Companies filed an Appeal Rider of 5.5% to be applied to the base rates of all classes of service until a total of \$1, 952,912 has been collected.

NOW THEREFORE IT IS ORDERED THAT:

1. The Appeal Rider attached as Appendix A is hereby approved.
2. The Companies are directed to report monthly to the Board with respect to the amount of the rider billed during the month and the time at which the total allowed sum of \$1,952,912 is expected to be collected.
