**ORDER 1997 - 3**

**WHEREAS:**

- A.        On November 17, 1995 Yukon Energy Corporation and Yukon Electrical Company Limited filed a General Rate Application for the test years 1996 and 1997.
- B.        The Board caused a Notice of Hearing to be published and requested interested parties to register their intent to intervene.
- C.        Nine intervenors were recognized by the Board and, pursuant to Section 56 of the *Public Utilities Act*, six intervenors, including the Utilities Consumers' Group, were granted intervenor costs. The intervenor costs were awarded in Board Order # 1996-10, issued on November 25, 1996, following a review of all submissions on costs and the merits of awarding costs.
- D.        The Utilities Consumers' Group advised the Board, in a letter dated December 14, 1996, of an error in the calculation of the UCG intervenor costs and in the subsequent costs awarded.
- E.        The Board reviewed the amended UCG claim, using the standards applied to all intervenor costs claims in Board Order #1996-10.


**ORDER:**

**THEREFORE IT IS ORDERED THAT:**

In addition to costs awarded in Board Order #1996-10, the Yukon Energy Corporation and the Yukon Electrical Company Limited shall pay the Utilities Consumers' Group \$2,081.25 in fees and \$363.42 in disbursements within 30 days of the issuance of this Order.


