WHEREAS:


- A. April 11, 1997, Yukon Energy Corporation ("YEC") and Yukon Electrical Company Limited ("YECL") (the "Companies") filed an Interim Refundable Rate Application to make rates interim refundable to April 1, 1997; suspend payments under Rider G; apply a rate surcharge of 20% to all customer classes; and to amend the Electric Service Regulations.
- B. The Board caused a Notice of Hearing to be published on April 25, 1997 requesting interested parties to register their intent to intervene at a public hearing scheduled for May 12, 1997.
- C. Nine applications for intervenor status were received and approved by the Board.
- D. Following a full public hearing, the Board requested applications for hearing costs and received applications from two intervenors.
- E. Board Order 1997-10, dated October 23, 1997 awarded hearing costs to both intervenors.

NOW THEREFORE IT IS ORDERED THAT:

In addition to costs awarded in Board Order 1997-10, the Companies are ordered to pay \$27,093.97 to the Government of Yukon for costs incurred by the Yukon Utilities Board to conduct the 1997 Interim Refundable Rate Application hearing.
