**BOARD ORDER 2007-09  
Amending Board Order 2007-07**

**WHEREAS:**

- A.     On September 25, 2007 the Yukon Utilities Board (Board) issued Board Order 2007-07 (Order).
- B.     At page 7 of the Order, the Board approves \$18,418.04 for Michael Buonaguro's fees and disbursements related to the 20-Year Resource Plan. The Order does not, however, include a cost award for GST of \$1,099.48, which Mr. Buonaguro is entitled to receive.
- C.     At page 7 of the Order, the Board approves \$6,919.00 for Mr. Buonaguro for fees related to the PPA matter. The amount approved is based on 40.7 hours, and the hourly rate of \$170.00. On September 26, 2007 Mr. Buonaguro advised the Board that he only incurred 39.9 hours, being \$6,783.00. In addition, the Order does not include GST of \$406.98, which Mr. Buonaguro is entitled to receive.
- D.     At page 8 of the Order, the Board made a calculation error with regard to Peter Percival's cost award. Specifically, the Board calculated Mr. Percival's approved costs of \$98.00 and \$2,756.25 incorrectly and

subsequently awarded costs of \$2,271.50. Mr. Percival's cost awards correctly total \$2,854.25.

- E. The YUB wishes to clarify the disbursements awarded to the Yukon Energy Corporation on page 10 of the Order. The disbursements of \$363,757.54 awarded for the 20-Year Resource Plan, and the disbursements of \$123,371.24 awarded for the PPA, are inclusive of consulting costs.

**THEREFORE, the Board amends the Order, as follows:**

1. The Board awards GST of \$1,506.46 for Michael Buonaguro.
2. The Board adjusts Michael's Buonaguro's cost award for the PPA matter from \$6,919.00 to \$6,783.00.
3. The Board awards costs of \$2,854.25 to Peter Percival.
4. The Board's direction on page 11 of the Order is amended to read as follows:

**NOW THEREFORE the Board orders as follows:**

Yukon Energy Corporation shall pay the following amounts to parties identified and that such payments shall be forthcoming within 30 days of the issuance of this Order. All hearing costs shall be recorded in a Hearing Reserve Account. YEC shall include in its next GRA a proposal as to the appropriate dispensation of the Hearing Reserve Account and a proper allocation of the costs in the account to the different rate classes.
