Summary of Application

The Yukon Electrical Company Limited (YECL) has filed an application with the Yukon Utilities Board (Board) for approval of its proposed revenue requirements for the years 2013 to 2015 inclusive (Application). YECL is a distributer (with some generation) of electrical energy in the Yukon and provides electrical service directly to more than 16,700 retail customers in 19 communities from south of the Yukon border to north of the Arctic circle.

YECL is seeking approval of revenue requirements of \$54,956,000 for 2013, \$58,707,000 for 2014 and \$61,187,000 for 2015.

In addition, the application addresses among other things, the following matters:

- Approval for the continued use of deferral accounts as listed in the application;
- Approval to discontinue purchasing third party distribution line (property) insurance after July 1, 2014;
- · Approval for updated depreciation parameters;
- Five-Year Yukon Demand Side Management Plan; and
- International Financial Reporting Standards Changes

YECL is also requesting approval of interim refundable rate riders effective July 1, 2013.

Pending Ministerial approval, an oral public hearing of the Application is tentatively scheduled to commence at 9:00 a.m. on Monday, **November 4, 2013**, at a location to be determined in Whitehorse, Yukon. The oral hearing is tentatively scheduled for three days.
