### BOARD ORDER 2026-02

#### WHEREAS:

- A. On December 20, 2024, ATCO Electric Yukon (AEY) and Yukon Energy Corporation (YEC) (jointly the Utilities), filed an Application with the Yukon Utilities Board (the Board) pursuant to *the Public Utilities Act* (the Act) and *Order-in-Council 1995/90*, requesting an order approving certain updates to the Terms and Conditions of Service (T&Cs). The Application sought approval of:
- Updates focused on modernization of the T&Cs;
  - Updated Maximum Investment Levels (MIL) based on an MIL Cost Study including an inflation mechanism for future years; and
  - Updated Fees and Service Charges to reflect changes in operations including an inflation mechanism for future years.
- B. The Board issued Board Order 2025-13 on September 8, 2025, its decision on the Application in which it ordered as follows:
- AEY and YEC shall submit a compliance filing to the Board within 30 days of issuance of this Board Order, in accordance with the directions set out in the reasons found in Appendix A to this Order.
- C. On October 8, 2025, the Utilities filed their compliance filing pursuant to Board Order 2025-13.
- D. The Board issued Board Order 2025-15 setting out the process for the

compliance filing setting October 31, 2025 as the date for intervener comments and November 10, 2025 as the date for reply comments from the Utilities. Mr. Maissan asked for a one-week extension to November 7, 2025 for intervener comments which the Board granted and also granted the Utilities an extension for reply to November 17, 2025.

- E. The Board received intervener comments by November 7, 2025 and reply from the Utilities by November 17, 2025.
- F. In accordance with the revised proceeding schedule for this proceeding, the record for the compliance filing proceeding closed on November 17, 2025.
- G. In making its decision, the Board has carefully considered the evidence and submissions of the parties. For the reasons set out in Appendix A to this Board Order, the Board has not approved the compliance filing as filed.

**NOW THEREFORE**, the Board orders:

1. the Utilities to revise the Terms and Conditions of Service in accordance with the directions and reasons given in Appendix A attached to this Board Order; and
2. the Utilities to submit the revised Terms and Conditions of Service as an acknowledgement filing to the Board within 30 days of the issuance of this Board Order.
