BOARD ORDER 2008-4

WHEREAS:

- A. On April 30, 2008, Yukon Electrical Company Limited (YECL) filed with the Yukon Utilities Board (Board) an Application, pursuant to the *Public Utilities Act* and *Order-In-Council 1995/90*, requesting an Order approving forecast revenue requirements for the 2008 and 2009 test years and approval of certain deferral accounts (General Rate Application or Application).
- B. The Application also requests approval of an Interim Refundable Rate Rider, Rider R, and Temporary Refund/Surcharge Rider, Rider G, commencing July 1, 2008, applicable to all YECL and Yukon Energy Corporation retail customers excluding Secondary Energy Rate 32 and Industrial Primary Rate 39 (Interim Application).
- C. The General Rate Application proposes a revenue requirement of \$46,660,000 for 2008 and \$47,902,000 for 2009, representing increases over revenues from existing rates and riders of \$2,200,000 or 5.9 percent for 2008, and \$4,130,000 or 5.1 percent for 2009, excluding fuel prices.
- D. The General Rate Application seeks approval to continue deferral accounts to reflect flow through of costs for Purchased Power and Fuel Prices, and to continue the deferral account for the Diesel Contingency Fund.
- E. The General Rate Application also proposes new deferral accounts to cover potential increased fuel costs associated with Pelly Crossing (Increased Fuel Costs Associated with Pelly Crossing Deferral Account) and a deferral account to cover potential changes in income tax rates (Income Tax Rate Variance Deferral Account).

- F. The General Rate Application also requests that certain affiliate costs be held as placeholders until such time as the Alberta Utilities Commission (AUC) rules on these costs as part of the benchmarking process before the AUC respecting ATCO I-Tek Ltd. and ATCO I-Tek Business Services Ltd., an affiliate of ATCO Electric Ltd.
- G. The Board has reviewed the Application and requires that a Pre-Hearing Conference and Hearing process be established.

NOW THEREFORE the Board orders as follows:

- 1. A Pre-Hearing Conference into the Application will commence at 10:00 a.m. on June 12, 2008, at the Gold Rush Inn, Town Hall, 411 Main Street, Whitehorse, Yukon.

- 5. Not later than May 23, 2008, YECL shall cause to be published in display-ad format, a Notice of Application and Pre-Hearing Conference, as per Appendix A to this Order, in such appropriate local news publications in YECL's service area so as to provide adequate notice to the public.
- 6. YECL shall make the Application and supporting material available for inspection at YECL, 100-1100 First Avenue, Whitehorse, and at the Watson Lake and Haines Junction public libraries.
