**Re: 2008-2009 General Rate Application**

Yukon Electrical Company Limited ("YECL") is requesting an extension to the Board's current schedule. This extension is necessary given the significant amounts of IRs received compared to the company's resources and revenue requirement. Many of the approximately 700 IRs are extremely detailed in nature and it is simply not feasible for YECL to respond to this volume of IRs within the existing schedule, particularly given the availability of resources including counsel, that have been assigned to this proceeding. As well, YECL is also concerned that a number of questions require extensive work that may not be required in order to test the 2008-2009 revenue requirement.

This revised schedule still allows for the hearing to commence October 7, 2008.
