UCG is very concerned about this latest tactic by YECL or the new stand-alone company of ATCO Yukon.

Where in the procedural schedules are utilities allowed to submit reply comments on submissions made by parties related to cost claims?

Per the Board's June 2 email, parties were given until June 16 to submit comments on cost claims related to this proceeding. No provision was made for YECL to reply to these comments and there is no such provision within the YUB's Rules of Practice/Scale of Costs to allow claimants to keep adding arguments to the record.

YECL's supplemental comments and attempt to further justify their cost claim is a blatant attempt to circumvent the YUB's established procedures and should be ignored.
