Re: Nathaniel Yee Participant Cost Award claim for the 2025-27 YEC General Rate Application proceeding before the Yukon Utilities Board

This letter and the attached supporting information constitute my Participant Cost Award claim for the YEC 2025-27 General Rate Application proceeding.

Completed forms 1 through 4 are attached, along with a more detailed time record.

This is my seventh appearance in the last five years as an intervener before the Board. I provided input on affordability, feasibility and reliability, including that Yukon Energy's claimed timeframe for completing a permanent diesel plant in Whitehorse was inconsistent with its statements in prior GRAs, and noting that reliance on rental diesel reduces reliability particularly without the "spares" that Yukon Energy previously said were necessary. While the Board considered planning issues to be out of scope, it remained important to note that in this GRA (as in other recent GRAs) Yukon Energy again advanced a set of "must have" and "urgent" projects while offering only vague longer-term direction and failing to present clear alternatives.

I believe my ideas, approach and attention to detail added value to the process, and in a public hearing, input and analysis from members of the public is important to the validity of the process. I attended all days of the hearing. My time claim continues to be based on an hourly rate of \$55. I understand that the hourly rate is at the discretion of the Board.
